

RUE “National Airport Minsk” would like to express its respect and offer the handling and storing of cargo incoming/outcoming to/from the Republic of Belarus and transfer cargo flows.

The Republic of Belarus has an advantageous economic and geographical position at the crossroads of the most important transport European corridors.

RUE “National Airport Minsk” is situated in the centre of the Republic of Belarus, in 30km away from Minsk. The airport is the main air gateway of the republic in terms of its economic position. By the way, the airport occupies one of the leading places in Eastern Europe in terms of technical characteristics and operation capacity.

The railway road and Berlin-Warsaw-Brest-Moscow motorway lay close to the airport. The airport’s geographical location at the crossroads of the international highways from East to West and from North to South makes the airport convenient for transit flights.

In 2012, the airport handled 9821,63 tons of cargo (+13.3% as compared with 2011).

The total area of the cargo complex is 30 000 sq.m, temporary storage docks – 2 300 sq.m, storage docks for non-customs cargo - 360 sq.m, storage docks for customs cargo - 360 sq.m, storage dock for isotopes - 90 sq.m, refrigerator compartments – 230 sq.m, storage dock for dangerous goods – 90 sq. m, storage dock for valuable cargo – 40 sq.m, vehicle parking – 1500 sq.m.

The cargo complex is equipped with:

- TOYOTA forklift with lifting capacity of 1.5 to 7 tons
- Hydraulic trolleys load capacity of 1.5 to 7 tons
- Container and pallets dollies
- CHAMP 70U container and pallets loader
- CHAMP 35 autoloader for small LD 2, LD 3 containers
- Belt self-propelled and trailing loaders
- Intruder alarm system.

The capacity of the cargo complex allows to process up to 400 000 tons of cargo per year including such special types of cargo as AVI, VAL, DGR. Storage rooms make it possible to store normal, valuable cargoes, tax goods and biologicals.

The structure of the cargo complex of RUE “National Airport Minsk” includes a sales and customs clearance group. The group provides a package of customs services that includes:

- Customs registrations, verification and preparation of necessary documents;
- Submission of all the customs declarations types to the Customs Authorities;
- Customs clearance operations;
- Consulting in Customs Legislation and Foreign Trade Regulations.

The group consists of qualified specialists in customs clearance. Convenient operating schedule makes it possible to take into account any wishes and suggestions of the customer.

RUE “National Airport Minsk” is included in the Register of Customs Agents (№TA-0500/00000300 of 30.04.2004).
