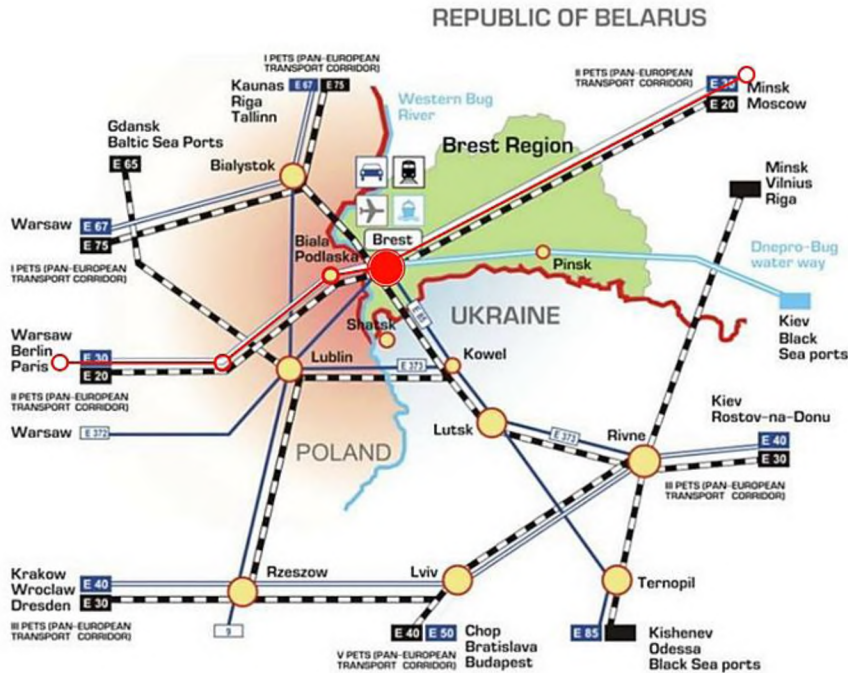

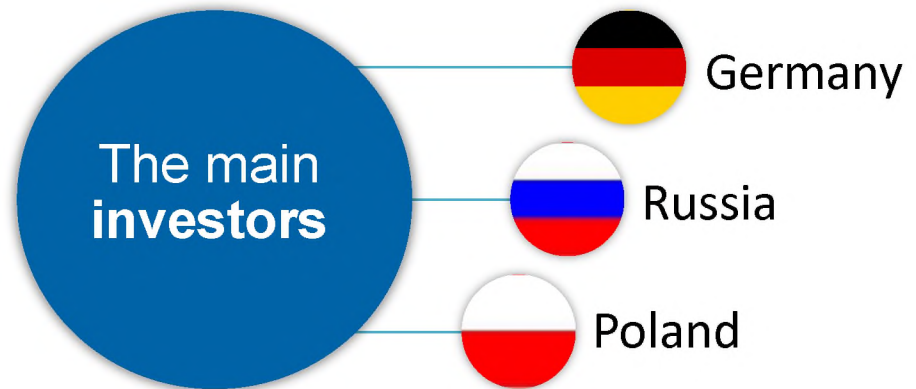
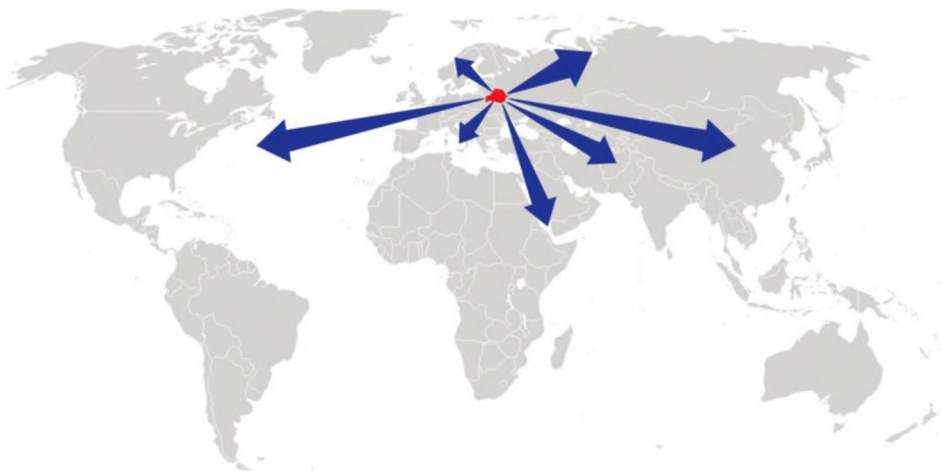

TAX incentives and CUSTOMS preferences

Residents of FEZ **are exempted from:**

- ❖ corporate profit tax (CPT);
- ❖ estate tax;
- ❖ land tax and land rent;
- ❖ obligatory sale of foreign currency



VAT FREE

The equipment and construction materials imported for the implementation of the investment project are **not the subject for customs duties and value added tax (VAT)**.

*These incentives are valid for the entire duration of FEZ **until 2050***

The minimum declared investment reduced from
1 million euro to 500 thousand euros
